SBTi Services checks and validates climate targets, validating the decarbonization goals of corporations, financial institutions and SMEs worldwide. By validating their climate targets, businesses demonstrate an understanding of their minimum decarbonization requirements by which customers and investors can measure them.

To be validated, companies must create greenhouse gas inventories and apply the Science Based Targets initiative's thorough methodologies for calculating decarbonization targets and submit these to SBTi Services for validation. Validators at SBTi Services check companies' and financial institutions' climate targets with standards developed by the Science Based Targets initiative.

SBTi Services is a trading subsidiary company, with any profits generated from commercial activities passed to its parent the Science Based Targets initiative, a charity registered in England and Wales.

Purpose

This document outlines the pricing for target validation services through SBTi Services Limited.

Tier Eligibility

Tiered Pricing Model

SBTi Services uses a tiered pricing model based on annual turnover and organization type. The tier and organization type are determined at registration, during which the latest financial statement is reviewed.

Table 1. Pricing Tiers

Annual turnover is presented in Euros to align with registration requirements, expressed in billions (B) or millions (M).

Corporate Tier	Annual Turnover Threshold
Tier 1	Less than €250m
Tier 2	€250m - €1B
Tier 3	€1B - €10B
Tier 4	€10B or greater

FI Tier Number	Annual Turnover Threshold
Tier 1	Less than €1B
Tier 2	€1B - €10B
Tier 3	€10B - €30B
Tier 4	€30B or greater
SME Tier Number	Annual Turnover Threshold
Tier 1	Less than €5m
Tier 2	€5m or greater

Discounts

Discounts are available based on annual turnover and country headquarters, as defined by the [World Bank's income classification](#) table. Companies must request a discount during registration to be considered and fee discounts will not be considered outside of the registration process. We encourage companies to pay the normal service fee if financially viable to ensure the discount can be reserved for companies that would benefit most from the discount.

Services and Pricing

1.1 Service Descriptions

All corporate and FI target validation services include a technical review, validation call, and validation decision statement. Additional details can be found in the [Standard Operating Procedure for the Validation of SBTi Targets](#).

Corporate validation results are delivered within 40 business days of the service start date, following the [Validation Schedule](#). FI validation results are delivered within 60 days of the service start date. SMEs receive a tailored validation service without a specific timeframe for validation results.

Near-term	Validation of new near term targets
Net-zero	Validation of long-term, net-zero targets. Requires approved near-term targets.
Near-term and net-zero package	Discounted package price for validation of new near-term and net-zero targets together. The package rate is only available when originally submitted as a package. Amendments to service type will be charged the full standalone service fee.
Near-term and/or net-zero update	Streamlined update of existing near-term and/or net-zero targets. One fee covers validation for both near-term and net-zero updates.
Near-term update and net-zero package	Discounted package price for updating previously approved near-term targets and validating new net-zero targets together. The package rate is only available when originally submitted as a package. Amendments to service type will be charged the full standalone service fee.
FLAG and/or buildings	Companies may be required, or choose, to set FLAG (Forestry, Land, and Agriculture) target and/or buildings sector target(s). Refer to the SBTi FLAG Guidance and SBTi Buildings Criteria for more information on the type of entities which are required to submit these targets. This is an add-on validation and must be submitted with another service. One fee covers both FLAG and buildings targets.
FLAG and/or buildings update	Updates to approved FLAG and/or buildings targets. One fee covers both FLAG and buildings updates.

FI Near-term	Validation of new near-term targets for FIs.
FI Net-zero	Validation of near-term and long-term, net-zero targets for FIs in line with the requirements of SBTi Financial Institutions Net-Zero Standard.
FI Near-term update	Streamlined update of existing near-term targets for FIs.
FI Buildings	Add-on validation of buildings targets for FIs. Must be submitted with another service. There is no additional fee to add buildings targets to FI services, <i>i.e. FI Near-Term and FI Net-zero validation fees are inclusive of this service.</i>
FI Buildings update	Add-on for updating approved buildings targets for FIs. Must be submitted with another service. There is no additional fee to add buildings targets to FI services, <i>i.e. FI Near-Term and FI Net-zero validation fees are inclusive of this service.</i>

SME Near-term	Validation of new near term targets for SMEs.
SME Net-zero	Validation of long-term, net-zero targets for SMEs. Requires approved near-term targets.
